The board discussed county-provided cell phones to conduct county business. Blackburn stated his concerns that recently their personal information is involved in litigation against the county. All members agreed that they didn't want to spend taxpayer dollars on this, but felt it was necessary. Motion by Shearer to approve the purchase of county cell phones for the board. Motion carried unanimously.

At 9:15 a.m., Sheldon moved to go into public hearing on the proposed 2025/2026 budget amendment. Motion carried unanimously. Present for this meeting were Owen, Sheldon, Shearer, Johnson, Berry, and Blackburn. At 9:17 a.m., hearing no comments and with no objections, motion was made by Sheldon to go out of public hearing.
