

The Fremont County Board of Supervisors met in regular session on Wednesday, December 24, 2025, in the Fremont County Courthouse Boardroom, with Clint Blackburn and Dustin Sheldon present. Let the record show Jeff Shearer called into the meeting. A quorum was declared, and the meeting was officially called to order at 9:00 a.m. The agenda was approved as posted. Minutes of the previous board session were read and approved.

Let the record show that Assistant Engineer Robbie Kromminga was present at this meeting.

Engineer Robbie Kromminga met with the board for the following:

Motion by Sheldon to allow Chairman Blackburn to sign application for approval of underground construction in county ROW for Black Hills Energy to remove a transmission line and replacement with a distribution system in ROW along 286th Street and Highway 275 north of Hamburg. Motion carried unanimously.

Motion by Shearer to approve Resolution No. 2025-46 regarding a correction on the hourly wage for lead persons at the Secondary Road Department. The union contract from July 1, 2024, had a clerical error. The resolution is to correct the wage from today on. Motion carried unanimously.

RESOLUTION TO CORRECT WAGE ERROR

WHEREAS, the Fremont County Secondary Roads Department was provided wage calculations by an outside entity.

WHEREAS, an error was found in wage calculations by a union representative regarding overpayment of wages for lead persons at the Fremont County Secondary Roads Department starting on July 1, 2024. The incorrect wage of \$26.67 began on July 1st, 2024 and continued through the new wage of \$27.60 on July 1, 2025. We would like to correct this as soon as possible to the correct wage amount of \$26.57. Additionally, Fremont County Secondary Roads Department will not be seeking reimbursement of overpaid wages. NOW THEREFORE BE IT RESOLVED by the Board of Supervisors of Fremont County that the Lead Person wage at the Fremont County Secondary Roads Department be corrected to \$26.57 for the remainder of fiscal year of 2025-2026. Motion to approve by Shearer.

Claims were approved for December 26, 2025.


At 9:10 a.m., with no further business, Sheldon motioned to adjourn. The motion carried unanimously.
