A quorum was declared, and the meeting was officially called to order at 9:00 a.m. The agenda was approved as posted. Minutes of the previous board sessions were read and approved.

Let the record show that Treasurer Alise Snyder was present at this meeting.

Motion by Sheldon to re-appoint John Long to the Conservation Board for a 5-year term ending 6/30/29. Motion carried unanimously.


There were no applications received for the Tourism Board. Motion by Sheldon to table the appointment for the Tourism Board. The motion carried unanimously. The opening will be posted again.

A quorum was declared, and the meeting was officially called to order at 9:00 a.m. The agenda was approved as posted. Minutes of the previous board sessions were read and approved.

Let the record show that Engineer Dan Davis, Attorney Peter Johnson, Recorder Tarah Berry, Treasurer Alise Snyder, and EMC Clayton Long were present at this meeting.

Engineer Dan Davis met with the board for the following:

They have a start date in July 1, 2024 and will end of February 2027. standard farm lease. The first two are with Marcus Lorimor located at 1537 199th Avenue, Thurman, IA; 1541 199th Avenue, Thurman, IA. Motion by Sheldon to approve the leases with Lorimor. The next lease is for 2027 155th Street, Thurman, IA with Newlon Farms. Motion by Blackburn approve the lease with Newlon Farms. Motion carried unanimously. The final lease for consideration today is with Sheldon Revocable Trust for 1795 225th Street, Percival, IA;. Motion by Blackburn to approve the lease. Clark, aye; Blackburn, aye; Sheldon, abstain.

RESOLUTION NO. 2024-48

RESOLUTION ESTABLISHING A COUNTY COMPENSATION BOARD

A resolution by Fremont County to establish a county compensation board as authorized by Iowa Code Section 331.905.

WHEREAS, pursuant to Iowa Code Section 331.905, as amended in 2024 by Senate File 2442, the county board of supervisors may vote to establish a county compensation board.

WHEREAS, pursuant to this same Code Section, when the board of supervisors establishes a county compensation board, the compensation board shall be comprised of seven members who are residents of the county. Two members shall be appointed by the board of supervisors, one member each by the county auditor, county attorney, county recorder, county treasurer, and county sheriff. The members of the county compensation board shall not be officers or employees of the state or a political subdivision of the state and shall serve staggered terms.

NOW, THEREFORE, BE IT RESOLVED, Fremont County hereby establishes a county compensation board for the county.

BE IT FURTHER RESOLVED, Fremont County directs each of the elected officials to submit their respective appointments to the board of supervisors by December 1st, 2024.

BE IT FURTHER RESOLVED, the representatives of the Supervisors, Auditor, and Sheriff shall serve an initial term of four years, and the representatives of the Recorder, Treasurer, and Attorney shall serve an initial term of two years.

BE IT FURTHER RESOLVED, this resolution shall apply retroactively to July 1, 2024.





The other property owner was adamantly against moving because they want their property protected. Olmstead said they will be putting a culvert in in the I29 right-of-way that will pick up the water and make sure the drainage is redefined. This should solve that landowner's current drainage issue. Olmstead showed where there would be a gate during flood events. Sheldon questioned how the water would be removed during those events and Olmstead said IDOT will pump the water out with portable pumps. Olmstead said if the the agreement is approved today they will make changes to the previous IDOT agreement and have it ready to sign. The IDOT is ready to move forward on this project and have set aside \$4.2 million for the project. Olmstead would like to start construction before harvest. He said they will come down with regular updates for the board. The county attorney has reviewed the engineering agreement and had no recommendations for changes. Motion by Blackburn to approve the to engineering agreement. Motion carried unanimously.
