

The Fremont County Board of Supervisors met in regular session on Wednesday, June 5, 2024, in the Fremont County Courthouse Boardroom, with Chris Clark and Clint Blackburn present. Let the record show Dustin Sheldon was not present for this meeting. A quorum was declared, and the meeting was officially called to order at 9:00 a.m. The agenda was approved as posted. Minutes of the previous board session were read and approved.

Let the record show that Engineer Dan Davis, Assistant Engineer Robbie Kromminga, Purchasing Agent Tommie Thompson, Attorney Peter Johnson, and Recorder Tarah Berry were present at this meeting.

Purchasing Agent Tommie Thompson met with the board regarding the proposal of the purchase of SD-7 communication devices to replace current vehicle radios at the secondary road department. Thompson stated the current radio is obsolete and the air conditioner that cools them is inoperable at the old sheriff's office. They are looking at the SD-7 radios. They are a data driven communication system. They used them on a trial basis. They worked well bouncing off local cell towers. Like other cell service there are a couple spots in Fremont County that don't have service. T-Mobile is purchasing US Cellular. The monthly cost for 30 units with equipment and data is estimated at \$750.00. They think they would need 32-34 units. They are hoping for a little better boost on tower signal when T-Mobile takes over. Motion by Blackburn to approve the agreement for the SD-7 radios. Motion carried unanimously.

Motion made by Blackburn to allow Chairman Clark to sign the Rural Transit System Joint Participation Agreement with SWIPCO. Motion carried unanimously.

Motion by Blackburn to approve Resolution No. 2024-37 to transfer funds from the Local Option Sales Tax Fund and Rural Services Fund to Secondary Roads. Motion carried unanimously.



They have talked to the DOT multiple times about the issues there. The state patrol didn't send anyone down to assist.

At 9:17 a.m., Assistant Auditor Cassie Gilbert joined the meeting.







The board discussed several meal per diem options including the GSA option provided by Sheriff Aistrope, a \$35, \$40 or \$45 per diem or a flat rate per diem with reductions based on if breakfast or lunch are provided. The board agreed that whatever option is chosen it will be a reimbursement with receipts paid directly to the employee not charged to a county credit card. A couple of department heads stated they aren't fond of not being able to use credit card and it was asked if an exception can be made if an employee can't afford to pay for the meals out of pocket. Blackburn stated they are looking for a fair dollar amount for both the taxpayers and employees. Motion by Sheldon to approve a \$45 reimbursable per diem to the employee, not charged on the county credit card, with the ability of the department head to ask for board approval for out of state trips if said trip is going to cost more. The Fremont County Board of Supervisors met in regular session on Wednesday, June 19, 2024, in the Fremont County Courthouse Boardroom, with Chris Clark, Clint Blackburn, and Dustin Sheldon present. A quorum was declared, and the meeting was officially called to order at 9:00 a.m. The agenda was approved as posted. Minutes of the previous board session were read and approved.

Let the record show that Engineer Dan Davis, Treasurer Alise Snyder, Jim Olmstead, Matt Woods, Attorney Peter Johnson, Recorder Tarah Berry, Sherrie Brink, Jeff Shearer, Leonard Tomlyn, Bruce Simpson, Tina Simpson, and, Jozie Parmer were present at this meeting.

Engineer Dan Davis met with the board for the signing of the following:

Motion by Sheldon to allow Chairman Clark to sign IDOT payment voucher with HGM Associates for engineering services for 3 miles of design of J-64 east of US Highway 275 per agreement through May 31, 2024. Motion carried unanimously.

This resolution will move resurfacing on L-44 from Thurman to J-10 and on L-68 from Highway 2 to Riverton from 2026 to 2025. Motion by Blackburn to sign 2025 5-Year Program Resolution 0.1 for Secondary Roads. Motion carried unanimously.

Attorney Matt Woods met with the board regarding the proposed drainage district at Highway 2 and I-29. Woods stated they took the suggestions from the last meeting and met with the landowners. He said they have heard from no one else. Olmstead has spoken to Hollimans. Two issues needed to be resolved. The field entrance and existing drainage issue in the northeast corner of the field. The DOT will be able to leave the field entrance as-is and they can fix the existing drainage problem while constructing the levy. They sent a letter to them on May 30<sup>th</sup> and have not heard anything back. They have heard from everyone else on a price per acre. Woods stated the Hollimans did not say yes or no. Woods said the price per acre is \$15,000. Leonard Tomlyn stated that he believes the project should be scrapped. He said the local flooding had nothing to do with the river the majority flows from Horse Creek and Mule Slough across the Kruse field. The DOT raised the ground by the highway and that will only affect Tomlyn and Kruse. There is a low spot south of his house and they blocked part of it on the Sapp property with mounds of dirt. There were only two major floods from the river and the rest of the floods were from Horse Creek and Mule Slough. Tomlyn questioned the cost to the county. Sheldon stated that this is not county dollars that funds this project it is funded by those businesses and the DOT. Matt Woods reiterated that the district has already been approved and this resolution is just setting the dollar amount for damages. The board questioned again that Hollimans had not been heard from. Woods and Olmstead said that they had not heard from them in favor or against. Tomlyn stated to go ahead but to move it down by the sewer lagoons. Sheldon stated he is uncomfortable not hearing back from Hollimans. He wanted all landowners to be agreeable. Blackburn asked if Tomlyn's concerns could be addressed. Olmstead said they would have to go back and take a look at it to see if moving the line south is viable. Motion by Blackburn to approve the resolution for the \$15,000.00 per acre for damages for the proposed district. Motion carried unanimously.

RESOLUTION NO. 2024-38

RESOLUTION ESTABLISHING CLASSIFICATION AND DAMAGES FOR HIGHWAY 2/I-29 CROSSROADS LEVEE DISTRICT

WHEREAS, affected landowners previously filed a Drainage/Levee Petition ("Petition") with the Fremont County Auditor in or around October 22, 2020, for the establishment of a levee system to be located at the Highway 2 and I-29 interchange located in Fremont County, Iowa; and

WHEREAS, in accord with Chapter 468 of the Iowa Code, Olmsted & Perry Consulting Engineers, Inc. ("Olmsted") was duly appointed to provide a plan and report for the establishment of such a levee district to protect property owners generally located at the intersection of Highway 2 and Interstate 29 in Fremont County, Iowa; and

WHEREAS, Olmsted has prepared and presented to the Fremont County Board of Supervisors an Engineering Report in accord with §468.14 of the Iowa Code dated August 31, 2021, and as revised February 21, 2022, for consideration by the Fremont County Board of Supervisors; and

WHEREAS, Olmsted presented the Engineering Plan to the Fremont County Board of Supervisors on March 23, 2022, and the Fremont County Board of Supervisors desires to tentatively approve said Engineering Report dated August 31, 2021, and as revised on February 21, 2022.

WHEREAS, the Report of Commissioners dated September 1, 2023, was duly presented to the Fremont County Board of Supervisors and a public hearing concerning the same in accord with the Iowa Code occurred on February 7, 2024; and

WHEREAS, the Report of the Commissioners dated September 1, 2023, recommending the method of land classification for future assessments in accordance with §468.184 of the Iowa Code should be approved, and that the damages for easement right-of-way to the affected land owners should be established at \$15,000.00 per acre.

IT IS THEREFORE RESOLVED BY THE FREMONT COUNTY BOARD OF SUPERVISORS AS FOLLOWS:

1. The classification for Highway 2/I-29 Crossroads Levee District should be in accord with the Report of the Commissioners dated September 1, 2023, and pursuant to Iowa Code §468.184 of the Iowa Code based on total assessed taxable value of land

and improvements, as determined by the Fremont County Assessor. Said assessment should be reevaluated not less than every two (2) years from the date of completion of construction of the levee system.

2. Damages to the affected land owners for easement right-of-way for the purpose of the placement of the actual levee system is hereby established at \$15,000.00 per acre.

Treasurer Alise Snyder met with the board to update them on tax sale results from June 17th, 2024. There were 178 regular parcels and 4 adjourned parcels. All 182 parcels sold for \$120,403.05. Snyder stated that she had 509 investors.

Treasurer Snyder spoke to the board about the deputies parking in the drive-test parking spot in the courthouse parking area. It is required by law that she have that designated spot for the drive test. Her employee has to do an inspection before the drive test and she is concerned for her safety if she has to perform the inspection in the street. Attorney Johnson said he will address the issue in his notice that he sends to the sheriff's office. Snyder also stated she has spoken to other department heads and asked if we could get our signs back that state specifically who the parking spaces are designated for. The board said they would ask maintenance to look for the signs and if he cannot find them to see if he could order new signs to replace them.

Motion by Sheldon to approve the renewal of the cigarette/tobacco/nicotine/vapor permit for Sapp Bros., Inc. Motion carried unanimously.

The board discussed a letter they received requesting an extension for nuisance compliance 2995 Swedish Road. Bruce and Tina Simpson showed the board pictures of the progress that they have made. The board told them to have Robbie come out to inspect their property and he can report back to the board and they can wrap it up if Robbie believes they have made sufficient progress. Motion by Blackburn to grant the 30-day extension. Motion carried unanimously.

Recorder Tarah Berry met with the board regarding a new hire for the vacant position in her office. Motion by Sheldon to approve the new hire resolution for the recorder's office. Motion carried unanimously.

Sherrie Brink spoke during public comment. She asked why the board had any right to address nuisance properties. She spoke about weeds blocking views at intersections. Blackburn addressed Ordinance 2010-1 which addresses laws regarding nuisance properties and having hazardous and unsafe items on properties. Blackburn welcomed information regarding weeds in ditches. Brink stated she has had numerous problems with trash in ditches and signs down. Blackburn stated that they rely on people like Brink to turn things like that in and they will do their best to get it taken care of. Leonard Tomlyn also spoke about Les Robbins' thistles and a cottonwood grove whom he is not sure who owns. Jeff Shearer then asked how those things are considered nuisances but a 590' turbine isn't. He said people are ready to move now. He said his house was built in 1892 and is a county treasure. He thinks he will never be able to sell it. He said we need people to move into the county and they won't if we have turbines. Shearer said no one in the county wants them. Treasurer Snyder discussed the lack of industry and revenue in the county. Auditor Owen also addressed the lack of revenue in the county and that being the reason for continued tax increases. Owen addressed that the citizens should be concerned about the unfunded mandates passed by the state legislature and how those are affecting Fremont County. After much discussion, the board was going to speak to someone at the road department and to the weed commissioner about these issues.
