The Fremont County Board of Supervisors met in regular session on Wednesday, June 4, 2025, in the Fremont County Courthouse Boardroom, with Clint Blackburn and Dustin Sheldon present. Let the record show that Jeff Shearer was not present for this meeting. A quorum was declared, and the meeting was officially called to order at 9:00 a.m. The agenda was approved as posted. Minutes of the previous board session were read and approved.

Let the record show that Engineer Dan Davis, Dave Roberts, Shad Smith, Nick Golden, Dana Herrs, EMC Clayton Long, Sheriff Kevin Aistrope, Sergeant Ashton Luke, and Assistant Auditor Cassic Gilbert were present at this meeting.

Motion by Blackburn to approve Resolution No. 2025-29 to transfer funds from the Local Option Sales Tax Fund and Rural Services Fund to Secondary Roads. Motion carried unanimously.

Auditor Owen Discussed the purchase of new election equipment. The software they currently use will require updating to laptops with Windows 11. They watched a demo of a new system called Tenex. It is more user friendly for PEO's and voters. The amount is \$14,703, half this year and half next year and \$945 annual fee.

There will be an opening for the Tourism Board for the term expiring 6/30/25. Motion by Sheldon to post the opening for Tourism Board. The motion carried unanimously.

Sheriff Kevin Aistrope met with the board to discuss deputies' wage reconsideration. Sheriff's Office lost two more deputies because of money related. The Iowa Code, Back the Blue, states we must give the Sheriff's Office more money to operate. Aistrope said the overnight shift got a \$2.00 increase for the jailer but the deputies on overnights did not so that is terrible for morale. Aistrope would like to get them up to \$75,000 for morale. He would like to start a stair step effect. Aistrope has 7 deputies and we are contracted with three cities. He will renegotiate with those cities to try to offset the salaries. Aistrope said he can use the room and board to offset some of the salaries. Aistrope says a quick solution would be to use room and board revenue for some of the jailer's salary and use the other money he is saving to give it to the deputies. In the end game, Aistrope wants the deputies up to \$75,000. Sheldon asked what deputies were leaving. Aistrope mentioned that they lost Wake to the roads department and Degase with the K9. Degase will be taking the K9 with him to Mills County. Sheldon asked what compensation we would get for the K9. Aistrope said we will not get anything in return for Degase taking the K9 to Mills County. Aistrope is giving a good avenue to pay for the raises with the room and board for two years. Blackburn stated the County is not growing so when we get revenue it goes right back into the county, so the departments do not reap the benefits. Sheldon asked what sustainability is in using the room and board revenue for wages. Aistrope stated there isn't any, it would only be feasible for 2 years. Sheldon stated that is the point, if you can't come up with \$100,000 in your budget in two years when the room and board revenue does not cover your wages. Sheldon asked Aistrope if he would be able to cut his budget in other places to cover the raised wages. Aistrope stated in 2 to 3 years I will have the cities contracted to pay the right wages. Aistrope also said if we can hold more people in the jail from other counties, we will have more revenue coming in that way. Blackburn said we will never be able to compete with our neighboring counties with our tax base with our deputies' wages. Blackburn stated not to fill one position and then pass that wage out to the deputies still on the payroll. Blackburn said that it has been discussed in meetings previously. Aistrope said that wasn't an option. The reason for this is because of the Interstate 29 and the extra patrol they do on the Interstate. Aistrope said we have more to patrol than neighboring counties. Aistrope mentions everyone around us pays more than us and if we don't start paying more, we are going to lose more deputies. Then we will end up wasting \$50,000 every time we have to hire a new officer by sending them to the academy. Sergeant Luke just wants to be competitive so Fremont County can keep their deputies. Blackburn stated we would like to give you the money, but Fremont County does not have the money to give out. Luke understands that we do not have the money but would like to find a solution, so we do not lose any more deputies. Sheldon said if we would give out raises you are asking for this year. Next budget year comes around someone might not have a job due to not having the funds to pay them. Sheldon then stated that Aistrope did

not have to take his huge pay raise, and he could have given his raise out to his deputies to make the salaries more appeasable for them to stay in Fremont County, but he didn't. Aistrope agreed that he did take his pay raise and could have split his raise with his deputies but didn't. Aistrope said if he loses a jailer, he could absorb that salary in 3 years. Aistrope wants to use the room and board for three years for wages. Blackburn stated that we cannot decide today without looking over the numbers and the budget. Sheldon mention to table it till next week after they have looked over the budget. Motion by Sheldon table next week, carried unanimously.

Motion by Sheldon to table the topic of the old law books upstairs at the county attorney's request. Motion carried unanimously.

During public comment, Clerk of Sidney Township Dave Roberts said he is worried that if they put in cattle guards and cattle still get out they will still be responsible for the injury. In the minutes from the 1980s Roberts found it stated the township agreed to pay up to \$400 to install, not to purchase. Shad Smith said it's been going on 3 to 4 years. Cattle have been getting in and out for years. These cattle guards are homemade, and they do not work. Roberts stated if they put up \$20,000 and the cattle still get out how are they still responsible. Shad Smith stated that the township should be responsible for putting in a new cattle guard for safety concerns. Roberts wants to know the Iowa Code about fence law. Roberts needs a clear idea of what Smith wants the township to do. Blackburn stated that the key factor is the cemetery and putting up a gate would be one solution instead of not having cattle guards. But a gate wouldn't allow people to come and go to the Grandview Cemetery. Smith said the cattle guard could cost between \$8500 to \$15000. Smith states he has no say about what gets done but he is just worried about the safety of the situation. Sheldon said to have this issue on the agenda for next week.

During public comment, Dana Herrs said he is trying to get back to his property in Bartlett. The gap between sanitation employees has put a huge issue on him reaching out to his contractors. Engineer/Zoning Dan Davis said that a meeting has been set for June 23rd. Herrs just stated he is trying to do things right and just wants to go back on his property. Davis mentioned that he will be an advocate for him with the board of adjustment. Blackburn said he wishes he had a good answer for him on this. Herrs is asking for a reasonable timeframe to line up for his contractors. Davis asked him to show up to the board of adjustment meeting on June 23rd so he can state his case and then he will get his final answer.

Jeff Shearer was present on the telephone. Let the record show that Dustin Sheldon was not present for this meeting. A quorum was declared, and the meeting was officially called to order at 9:00 a.m. The agenda was approved as posted. Minutes of the previous board session were read and approved.

Let the record show that Jeff Shirley was present at this meeting.

Maintenance Superintendent Jeff Shirley met with the board to discuss and sign a proposal for a new box on an existing dump truck. Motion by Shearer to make the purchase. Motion carried unanimously.

Chairman Blackburn phoned Chad Johnson to discuss building a crossing over a drainage ditch at their new house at 1239 Western Avenue in Thurman. He is requesting the ability to make a crossing over the ditch in his yard and was told to come to the board. Blackburn told him others in that area have been approved. This is the issue we have with steam that could affect our wiring in the storage room off the break room. This has been an ongoing problem that hasn't been addressed until this year. Auditor Owen recommended using LOSST infrastructure funds to avoid using too much of the maintenance budget. Motion by Shearer to use LOSST Funds for the repairs in the coming year. Motion carried unanimously.

The Fremont County Board of Supervisors met in regular session on Wednesday, June 25, 2025, in the Fremont County Courthouse Boardroom, with Clint Blackburn, Jeff Shearer. Let the record show that Dustin Sheldon was not present for this meeting. A quorum was declared, and the meeting was officially called to order at 9:00 a.m. The agenda was approved as posted. Minutes of the previous board session were read and approved.

Let the record show Alise Snyder, Treasurer, Scott Evans, IT, Dan Davis, County Engineer, Jack Reed, with INCS, Sheriff Kevin Aistrope, Sergeant Andrew Wake, Peter Johnson, County Attorney, by zoom.

Chairman Blackburn called Shad Smith, regarding the cattle guard. Blackburn stated that no one from Sidney Township are in attendance for this meeting. Blackburn requested updates on what needs to be done. County Attorney Johnson said we need to come up with a temporary solution that everyone can agree to. The original easement was from the 20s and the original easement has shifted. Johnson showed that the easement has shifted with a diagram. County Attorney Johnson said that '89 or '87 board of supervisor minutes agreed to replace the cattle guard. Shad Smith mentioned that the cattle guards had 1975 welded on the bottom of cattle guard. So, he doesn't believe it was ever done. County Attorney Johnson mentioned the Township Trustee's tried to make a homemade cattle guard to make do. Johnson doesn't believe that the homemade cattle guard helps them much for this problem. Johnson asked Smith what we need to do so we have a permanent/temporary solution in place before he leaves town, what do you propose for the township to do. Smith would like a gate that opens when a car comes for the cemetery would be the best option. He is okay for them coming across his land he is okay with the easement on his land still. But he needs the township to understand that this needs to be their solution and their problem to solve. Smith said he will help with anything. Smith wants Johnson to know that the Township is trying to push the liability off on him and he needs Johnson to know that it isn't his responsibility or liability on this issue. Johnson is going to try and reach out to the Township trustee's to rectify a temporary solution.

Engineer Dan Davis met with the board for the following:

Attorney Peter Johnson met with the board through zoom for the following:

Public Records Policy, Intern has been working on this and will update on this when we have solid language. And everyone is on the same page.

County-Owned Lot Auction, Designation of Authority, Future Land Projects, Auction went well Lots in Hamburg as expected 2 interested landowners came in and had a minimum bid. Purchase agreements need signed by the board. With future auctions, we need to have higher starting bids. County Attorney Johnson needs authority from the board and any other necessary documents to sign.

Motion by Shearer to sign the Purchase Agreement/Designation of Authority, motion carried unanimously

Old Law Books Upstairs, there are old code books we use to sponsor an old law library. Johnson wants the authority to get rid of the old law books that we have no use for anymore. Shearer asked what he would do with them. Johnson said he would ask around if the lawyers in the area would want them, if not he would dispose of them.

Motion by Shearer to give authority to dispose of old law books, motion carried unanimously.

Sheriff Kevin Aistrope met with the board to discuss deputies' wage reconsideration. Aistrope is still not at what the state recommends his salary is supposed to be by the Iowa Code. Blackburn asked if the county is down two deputies. Aistrope answered yes, we are down two deputies right now. All the applications we have in right now are uncertified applications. Aistrope stated we have lost all our deputies due to wages over the last year. The reason we lost the last deputies is because of the night shift differential. Aistrope was embarrassed when the posted job was for \$56,000. This job is a dangerous job, and the salary should be higher. Johnson stated to the board you should consider the new rules the deputies have to learn, for example, examining evidence and testifying on stand. The high turnover doesn't just affect the sheriff's office it affects the County

Attorney's office side of it too. Aistrope stated the deputy we lost that went to Mills County he picked up \$10,000 more and he moves up in pay after so long. Aistrop mentioned that our deputies do not move up in pay after so long we have to wait for the new budget year. Aistrope is asking for a \$10,000 per deputy to get them up to a comparable rate with other counties, so we aren't losing so many. Blackburn asked if Jack had anything to add. Jack Reed with INCS said if you as Board members have money to beef up the salary then you can. Reed stated that you can't guarantee the Sheriff's Office will not be asking for another increase in salaries in six months. But Reed doesn't have anything against increasing the salary. Shearer doesn't understand how he can ask for money from the county when we are already in a deficit. Aistrope said we will still be at a deficit when we keep having to train the employees. After hiring two new ones and sending them to train it will still put us in a deficit. Shearer said we can cut down on the deputies to pull from that salary for the raise. Aistrope said he won't do that we need those deputies. Aistrope said we are almost as busy as Pottawattamie County due to Interstate 29. Aistrope said keeping all the deputies is doing a service to the community. Blackburn stated we do not have the money to give out the extra salaries, it's not like we don't support you we do, we just can't do it. Aistrope said I can foot the extra money from the room and board for jail help. Blackburn brought in Dee Owen, to ask about the Room and Board from general fund. Dee Owen, Auditor stated it is a reimbursement to the general fund. Blackburn states that you can't use it for deputy salaries. Aistrope says it must be for jail related purposes. Aistrope stated the county has lost four deputies just this year. Blackburn couldn't agree more that it is a serious problem. As Board of Supervisors, it's hard-to-find money to give out an increase in salaries. Aistrope states if he gets four new deputies he will have to do a budget amendment. Aistrope also mentioned if he could find \$30,000 in his budget and if the Board of Supervisors could find \$30,000 in their budget somewhere. Aistrope could make the raises work somehow. So, he wouldn't have to rehire and rehire again. Blackburn said he would have the budget director look into it. Blackburn said this is the worst part of the job telling them that they can't have the money for the raises. Shearer said try the one deputy short for a while and see how it goes and see if safety and coverage are going to suffer. Aistrope said we can, but it will cost you in overtime. We have three towns that are paying us a portion, but we must ask them if we can cut hours from them. And after the 1st of July we are going to renegotiate the contracts. So, we will hopefully get more money from the towns. Aistrope said \$10,000 per deputy raise would bridge the gap for everyone to keep them happy and with that the last one wouldn't have left. Blackburn stated to let us talk with the budget director to see what we can come up with, but I am not promising you anything. Aistrope asked Sergeant Wake if \$60,000 will be a good whole amount for the raises. Wake responded with yes that should be good. Shearer said we can't force you to not fill the one position that is empty. Aistrope said yes but next budget year you can cut a position, but you would probably have a lawsuit if you did that. Blackburn wants to set a goal for the County, that goal is for everyone to work together. Blackburn states he doesn't know where the money will come from for the raises but he will speak with the budget director and get back to Aistrope.
